TPA is an intermediary organization licenced by the insurance company, with whom you have a mediclaim policy. The TPA is licensed by the insurance company to pay bills on your behalf to the provider hospital. It provides you (the policy holder)with information eg. network hospitals, terms & conditions etc.

**PROCEDURE TO BE FOLLOWED TO AVAIL CASHLESS HOSPITALIZATION:**

- 1) Have your original TPA card , photocopy, ID proof along with all prescriptions & investigations ready
  
- 2) Your pre-authorization form will be filled by hospital authorities and sent to TPA.
  
- 3) Admission in emergency is done however a security deposit is made by patient which is refundable once the authorization comes.
  
- 4) The authorization process may take few hours to a day.
  
- 5) Depending on the authorization amount ,the pending amount of the final bill if any, which is not sanctioned by the TPA is to be settled by patient.
  
- 6) Admission for investigations or OPD payments are not covered by any TPA
  
- 7) Any other query can be settled by the hospital authorities
